Information and Fee Schedule

Extended Day Availability

Early Morning Care (free of charge)

ECC Students: Mon-Fri, 7:00-8:00 a.m. (held in dining hall)

Grades 1-8: Mon-Fri, 7:00-7:45 a.m. (held in dining hall)

After School Care (fees listed below)

ECC Students (fees listed below): Mon, Tues, Thur, Fri, 2:45-6:00 p.m.; Wed, 2:00-6:00 p.m. (In ECC)

Grades 1-6 (fees listed below): Mon, Tues, Thur, Fri, 3:00-6:00 p.m.; Wed, 2:15-6:00 p.m. (In Dining Hall)

Grades 7-8 (free of charge if registered): Mon, Tues, Thur, Fri, 3:00-6:00 p.m.; Wed, 2:15-6:00 p.m. (In Cyber Café)

Fee Information

Registration Fees (annual)

\$30.00 individual student; \$50.00 family

All students planning to use EDA must register and pay the annual registration fee, whether attending on a full time, part time or drop-in basis.

Full Time Fees

Fee: \$190.00 per month, prepaid

Full Time students are those students who attend EDA more than three days a week, and will be in attendance beyond 4:00 p.m. The fee of \$190.00 must be paid by the 15th of each month, beginning September 2011 and ending May 2012 (9 payments). Any accounts not paid in full by the 15th of each month will be assessed a \$25.00 late fee.

Part Time Fees

Fee: \$145.00 per month, prepaid

Part time students are those children who attend EDA a maximum of three full days a week (beyond 4:00 p.m.), or five days a week with pick up by 4:00 p.m. The fee of \$145.00 must be paid by the 15th of each month, beginning September 2011, and ending May 2012 (9 payments). Any accounts not paid in full by the 15th will be assessed a \$25.00 late fee. Students enrolled in the part time program will be charged the \$15.00 drop in fee each time they are in attendance more than three days in one week or beyond 4:00 p.m. under the five-day option.

Drop-In Fees

Fee: Regular Drop-In, \$15.00 per day, paid daily

Extracurricular Drop-In, \$8.00 per day, paid daily

Drop-In students will be accepted on a daily basis. The \$8.00 fee applies to a student who is coming to EDA to await the start of a school-sanctioned sports practice or other event. The \$15.00 fee applies to all other circumstances. The drop-in fee must be paid **on the day it is incurred**. The School does not send a bill for drop-in services. The full fee applies regardless of the amount of time the child is in attendance

**Please be aware that any child not picked up by the end of carpool (Mon, Tues, Thur & Fri: ECC - 3:00, Gr.1-8 - 3:15; Wed: ECC - 2:15, Gr.1-8 - 2:30) will be escorted to EDA and the full drop-in fee will apply. **

Late Pick Up Fees

The EDA staff realizes that unexpected events occur to all of us. Therefore, the first late pick-up (after 6:00 p.m.) is excused. On the second late pick-up, a fee of \$1.00 per minute, per child, will be assessed. All late pick-ups thereafter will be assessed a fee of \$5.00 per minute, per child. All late pick up fees must be paid on the day they are incurred.

Additional Notes

1. If your family has more than two children enrolled in either the part time or full time programs, the charge for the third and each additional child will be half.
2. If you are volunteering your time for a school-sanctioned program, there will be no charge for your child(ren) to attend EDA.
3. **Registered** Junior High students may drop in to EDA at no charge if they are registered and the registration fee is paid.
